

Access

If you take the JR line:

Approximately a 1-minute walk from the Chuo Exit on the Ginza side of Yurakucho Station on the Yamanote line or the Keihintohoku line.

If you take the subway:

Approximately a 1-minute walk from exit No.D8 of Yurakucho Station on the Yurakucho line. (Tokyo Kotsu Kaikan Bldg. is directly connected the subway)

Approximately a 3-minute walk from Ext No.C9 of Ginza Station on the Marunouchi line.

Approximately a 5-minute walk from Exit No.D8 of Hibiya Station on the Chiyoda line.
